SMOKE ALARM LAWS

Since 2007, property owners have had increased responsibilities regarding smoke alarms in their rental properties.

Legislation requires property owners to ensure:

- ✓ The required amount of smoke alarms are installed, they meet Australian Standards and are correctly located.
- ✓ Smoke alarms are tested and cleaned within 30 days prior to the start of each tenancy or lease renewal/extension, and each battery that is flat or almost flat is replaced.
- ✓ Smoke alarms are replaced before they reach the end of their service life or replaced immediately upon discovering an alarm has ceased to function correctly.

NEW SMOKE ALARM LAWS

From January 2022, for properties being sold, leased or an existing lease renewed, the new legislation requires owners properties to ensure that smoke alarms are:

- ✓ Installed in every bedroom, every hallway servicing bedrooms and every storey not containing bedrooms in the most likely path of travel to exit the dwelling.
- ✓ Interconnected to all other smoke alarms in the dwelling.
- ✓ Photoelectric type only.
- ✓ Comply with AS:3786-2014
- ✓ Powered by an enduring power source (either hard-wired to the building's electricity supply or contain a sealed battery that is capable of powering the smoke alarm for a minimum of 10 years from the date of manufacture).



From 1 January 2022, rental property owners must ensure compliance with the requirements of the new smoke alarm legislation.

BLIND CORD COMPLIANCE

Laws concerning the installation and supply of window coverings came into effect in January 2015. Whilst these laws only concern the supply of new window furnishings and are not retrospective, lessors have a duty of care to tenants and must ensure the property is safe to live in.

Lessors are responsible for ensuring that corded window furnishings meet with the mandatory safety standards.

WATER METER READINGS

SAFETY SWITCH TESTING

Quickcheck's safety switch tests are conducted by licensed electricians who generate a fault (not just press a test button) to ensure the safety switch will trip within the required time. All rental properties in Queensland are required to have safety switches fitted. Safety switches need to be maintained and tested regularly to ensure that they will work to save a life if an electrical fault occurs.

LIGHT BULB REPLACEMENT

The Residential Tenancies Act requires all light bulbs to be working at the time of a new lease. It is also a requirement that tenants replace broken or blown light bulbs during their tenancy.

However, due to various circumstances tenants are often unable to replace light bulbs.
