#### **NEW SMOKE ALARM LAWS**

Queensland properties sold or rented must comply with the new smoke alarm laws now!

Sale properties are required to have the smoke alarms upgraded prior to settlement.

The new smoke alarm standards will apply to *all* Queensland property owners and properties must be upgraded to comply before 2027.

#### What is required?

The legislation requires property owners to ensure that smoke alarms are:

- Installed in every bedroom, every hallway servicing bedrooms and every storey not containing bedrooms in the most likely path of travel to exit the dwelling.
- ✓ Interconnected to every other smoke alarm in the dwelling.
- Photoelectric type only and comply with Australian Standards (AS3786:2014).
- Powered by an enduring power source (either hard-wired or contain a sealed battery that is capable of powering the smoke alarm for a minimum of 10 years from the date of manufacture).
- Existing or previous 240 volt smoke alarms must be replaced with hardwired smoke alarms.

#### Do I need to upgrade my smoke alarms?

- Are my smoke alarms less than 10 years old?
- Are my smoke alarms functioning?
- Are my smoke alarms interconnected (do they all activate together)?
- Do I have smoke alarms in each bedroom (as well as other locations such as hallways)?
- Do I have smoke alarms on each level or storey of my home?
